
# TRAGIC LOSS FOR CHAMBERS LANDING

## **MOWING POLICY MINIMUM STANDARDS**

To Read in its entirety - click here -

#### **Improved Lots**

- Lawns/yards must be mowed on a regular basis to maintain a neat and attractive appearance, not to exceed nine (9) inches in height.
- Sidewalks and driveways will be regularly edged to keep grasses from encroaching on surfaces.
- Lawns/plants/shrubbery must be watered to maintain an attractive, healthy appearance.
- All dead plants, shrubs, limbs and trees must be removed in a timely manner.
- All shrubs, foundation plantings, trees and plants will be trimmed in an esthetically pleasing manner and trimmings removed from view after maintenance is performed.
- Trees shall be trimmed a minimum of eight feet up from the ground.

### **Unimproved Lots**

- Must be maintained free of underbrush, tall grasses and any other unsightly growth and may not exceed a height of eighteen (18) inches.
- All dead trees must be removed in a timely manner.
- Must be kept clear of fallen limbs and other debris.
- Trees shall be trimmed a minimum of eight feet up from the ground.
- Mandatory mowing will be rigorously enforced to negate the risk of wildfires and rodent infestation.

## SPECIAL AUGUST MEMBERSHIP MEETING

The Association conducted a special meeting of its members on August 16, 2014, at which the then-serving directors resigned and the members elected new directors. Over 79% of the HOA's members were present in person or by proxy at the meeting, which far exceeds the amount required by any quorum requirement applicable to the HOA.

Following the adjournment of the special membership meeting, the newly-elected Board of Directors convened a special meeting of the Board, at which they ratified all of the prior actions taken by the persons acting as the Board of Directors since February 12, 2012.

#### MOWING CONTRACT CANCELLED TO SAVE MONEY

On August 30, 2014, the Board of Directors discussed the current financial health of the Association due to the drain on Association funds by continued legal expenses. The Board concurred that the "contract mowing" of all roads and common areas would be immediately discontinued. Bob McWhorter, Matt Dulworth and Lanny Gilliam volunteered to keep these areas mowed through the end of the year, saving us a considerable amount of money.

For this reason, it is imperative that you **inform your mowing contractor to mow the entire property all the way to the road.** In the past, the road easements were provided as part of the mowing contract, however it is the responsibility of each lot owner. **Waterfront Lot Owners** – PLEASE keep the beach areas mowed and cleared. Bob and Lanny have been doing this for you, but now have their hands full mowing all commons.

# Eggnog Pumpkin Pie Recipe

1 can (15 ounces) solid-pack pumpkin

1-1/4 cups eggnog

2/3 cup sugar

3 eggs

1-1/2 teaspoons pumpkin pie spice

1/4 teaspoon salt

1 unbaked pastry shell (9 inches)



In a large bowl, combine the pumpkin, eggnog, sugar, eggs, pumpkin pie spice and salt. Pour into pastry shell.

Bake at 375° for 60-65 minutes or until a knife inserted near the center comes out clean. Cool on wire rack. Refrigerate until serving. Top w/whip cream & enjoy!
