Old Business:

Lawsuit Update: The Board met with the Plaintiffs in July in hopes of coming to an agreement. The Board could not accept the Plaintiffs demands and the Plaintiffs rejected the Boards offer. The Plaintiffs requested a formal mediation & for the HOA to waive a jury trial. The Board

rejected that request. The Board tried a formal mediation with the Plaintiffs previously, but to

no avail.

The BOD adopted a 2022 Annual Budget.

The BOD approved 2022 Regular Assessments. There will be no increase in Assessments for

2022. 2022 Regular Assessments will remain at \$770 per lot.
